## MINISTER'S REPORT

Despite 2020 being the year of vision, no-one saw what was coming. It will certainly go down as a significant year in history but also in the life of Redcliffe Uniting Church.

**2020 freed us in many ways.** Freed us from the routines that had become ruts. Freed us from what we had always done. Freed us from what we thought we had to do, to what really mattered. Freed us from arbitrary rules. Freed us to innovate. Freed us to say 'no' and to say 'yes'. No longer can we say, 'that can't be done': necessity is the mother of invention.

As many have observed, Covid-19, while slowing down many aspects of life, actually sped up others. Churches that were in decline, declined further. Churches that were seeking to follow and grow, grew. Was this God sifting?

I'm so glad to report that what we were seeking to be and do at Redcliffe Uniting has stood us on solid ground. In a crisis, stasis and confusion are often the enemies. I am grateful that as a community we were not paralysed, that as the leadership led, we trusted God in them, and moved forward together. In many ways we are a different church. And we have grown, spiritually and numerically.

It's hard to believe that Becky and I started the year in New Zealand on long service leave, with Fritz Venzke in supply. It seems so long ago now. In March we were preparing for a forward vote on our Community Hub, and Fritz's departure, when Covid struck. Most ministries went immediately into lockdown, and worship went online on Sunday March 22nd [almost a year ago as, I write this.]

I must have lived three weeks on adrenaline as we worked out what it meant to be an online community. Paddi, Marion, Joy, Becky and I - supported by the office team - updated our pastoral lists, rang everyone in our directory, and saw our email list grow by 33%. A group of **Pastoral Carers and Callers** stepped up to connect with everyone during lockdown [we have 350 people in our community].

Playgroup and Jzone went online, and volunteers called all our playgroup families. Tech volunteers helped people access our online services. We sent out 50 DVDs of our Sunday services each month. We started to 'Zoom' our meetings, and after online worship we prayed, via Zoom, for our community's health.

With a bit of trial and error we developed an online style that has served us well. It has been a blessing to people who can't get back to face-to-face worship because of health issues or distance. We have a growing number of online worshippers from WA, NSW, VIC, rural QLD, and wider Brisbane.

We had a number of people move to be closer to family when the pandemic arrived: Bruce Williams, Sue Ramm, Joan Jay, Rev Ian & Val Taylor, while Alissa Gates and Fritz Venzke moved on to other opportunities.

We had to completely re-think our Hub vote. Firstly - was the timing for this project right? Secondly - how would we vote when Uniting Church regulations state that 'God moves in the gathering of His people'!

I was so encouraged by the courage of the Church Council and Hub Steering Committee, who worked through the issues and risks and decided "***If not now, when? Isn't a crisis the very time the church should act? The Hub becomes more significant than we ever thought in terms of helping our community recover.***" We pressed ahead. Produced more information than we otherwise would have. Addressed many questions. And received your vote of approval through an online process.

Finally, we got to breathe and develop an online rhythm. Paddi didn't let Covid put a stop to Alpha; in fact, it gave people a chance to 'gather' and 'get out', especially our Melbourne friends. We were also able to do some work on our property, thanks to volunteers and a grant from Moreton Bay Regional Council.

In the middle of all this we were shocked when Dave Trotman suddenly passed away. Dave did a mountain of work as our treasurer and with the property and sound teams. It was a very sad thing to lose Dave, and we continue to pray for Elaine.

Becky and I decided we should build a house in Rothwell, with all the Government incentives. We actually reduced Becky's hours at church as playgroup was no longer running, then she picked up more work at school. I really enjoyed the challenge of online preaching and believe it helped me grow as I explored this new medium.

Because of our community's response and people's compliance, we really did escape the worst of Covid. That's not to say that many people's lives weren't affected and that the ripple effects won't be felt for years.

Our initial financial worries for RUC were soothed by consistent giving from you, our people, and from the JobKeeper rollout. We truly were blessed.

Just as we got into the swing of being an online church, we had to re-adjust to live **and** online worship. We identified being online as an important ministry moving forward, and so a team was developed to record and edit videos - including Glenys Mullan, Janida Owen, and Dayney Tukutama - while another team, led by Patrick Sheahan, developed our online presence. Being online is opening our front door wide, allowing people to explore and sample us before coming in for more. And people are coming.

So, we slowly came back to face-to-face worship, home groups, and activities. Many have quite rightly chosen to remain online for their health, but this did mean that many of our volunteers weren't available or took the opportunity to 'retire' after long and faithful service. We are grateful to all who served. We have since set up new teams and recruited new folk in various areas.

God was faithful! Decisions we had been putting off we were now able to make, and new people began to put their hand up for roles we had struggled to fill. In fact, numerous people have come out of Covid with a new availability - which has been a real blessing. There is a definite increase in the number of younger people contributing. Becky even started a drama and dance group *during* Covid - amazing! - which has been a blessing for all.

Then, just as Paddi and Glenys were feeling like their time at RUC was coming to an end, UnitingCare approached us about partnering with us in a Community Chaplaincy role. This was a humbling opportunity, and we could see a fit with our Generations Pastor role - such that we were able to call Rev. Tim Griggs in 2021 to a new Youth and Community Chaplaincy position. Becky and my decision to build a house proved fortuitous, as Tim and Andi and their kids needed a Manse!

Since coming back to live worship, we have steadily increased in numbers. Every week we have also been blessed with new people in worship. The number of children in worship is increasing, too. God is moving in people's lives and in our community. We celebrate every time we see old faces return and new faces join us.

Now, as immunisation is taking effect *in* the community, and our Hub development is progressing *for* the community, we are on the verge of a new era at Redcliffe Uniting. It's hard to imagine what it will look like, what it will feel like, what it will be like, but we do know that we move into this future together with God.

In 2020 we said farewell to these dear saints who passed on to Glory: Gordon Tong, Dave Trotman, Merle Morgenstern, Janelle French, Lorraine Hewson, Anne Zander, Val Painton, Uneta Naylor, Robyne West, Val Fisher, Colin Weier, Rev. Ian Taylor, Raymond Barnett, and Elizabeth Reeve.

We also saw people move on to greener pastures or other opportunities: Rev. Paddi and Glenys Mullan, Ian Russell, Ben and Julie Fisk, Joy and Russell Godfrey, Tania Russell, Ian Campbell, Roslyn Core, Rachel Sampson, Margaret Smith, Val Taylor, Fay Fisher, Rob and Carol Hogan-Baker.

Covid isn't over. God isn't finished with us. Life isn't easy. But we continue to journey on, and it's so good to journey as a community in Christ.

## ADMINISTRATION

2020 was a year like no other. Paul, Becky, Paddi, Fiona, Robyne, Alissa, Chantelle, Fritz and Jeremy were on staff at the start of 2020. Fritz, Alissa and Paddi moved on to other opportunities at different points in the year. Some staff member's roles changed in 2020, for example Becky's role when playgroup could no longer meet in person, the Clarks reduced her hours and Becky then got more work at schools. Chantelle's role changed too, as she took on more responsibility and her hours increased as she prepared to step into more of the administration role, with Robyne's retirement on the horizon.

With Covid we all had to adapt to new methods of working. Most of the team worked from home for the majority of the time at the height of the pandemic. We became more tech-based and more mobile than ever. These changes led to new tasks, like doing church services, Jzone, and playgroup lessons completely online, and creating DVDs of our services to send out to those in the congregation who weren't able to go online. We increased the regularity of our staff meetings, and had them on Zoom. These are just a few of the many changes.

Robyne and Chantelle used this time, when some of our regular tasks weren't possible, to digitalise our records in a whole new way. The RUC office had recently moved over to the the Google Drive system, and countless files had to be moved over online from our old database. Having the database available this way meant that we could significantly reduce paper use and storage and that no worker would be limited by their type of device (all devices in good condition should be able to use/access Google Drive). It was also so convenient to have the database accessible from anywhere, and made the transition for those working from home easier.

It must have been a season of change, because Synod drove a change from older church personnel systems to a system called Ucare. We were already using Ucare for playgroup, but we moved the rest of our database over from the 'Pastoral Care 13' system to this one. This, of course, took some time, as we had to be sure we got everyone in the system [including their details, as this new system can also produce directories], and we had to learn the new system. The change was worth it, because of all that can be done through Ucare.

You may also have heard, through Paul's regular emails, about the various renovations happening around the church in 2020. Once the new toilets were installed we had all this wonderful space from the old ones to use. So, a storage room was built for the church and Uniting Care, and RUC's kitchen was extended. The church office was also renovated during this time. It got a fresh coat of paint, new carpet, and some new decor, and now looks much more professional. Fiona lead this office transformation, and we had some truly invaluable volunteers throughout - you know who you are! 2020 turned out to be such a great opportunity to have all of these renovations done.

We were blessed again with wonderful volunteers to help with administration - Candy Hunter, Gordon and Margaret Best, Jeremy Jacobs, Glenys Mullan, Val Hayes-Evans, Fran Hollywood, Carol James and others who 'just happen' to pop in and offer to help. We appreciated the regular visits/check-ins from our Church Council Chair, Bob Zander (when Covid wasn't at its worst), and are very grateful to Elspeth Sheahan for the work she has done as the Covid warden for RUC in 2020, including all the meetings regarding Covid that she attended on RUC's behalf. We also commend the prayer groups and intercessors, who pray over RUC and all those connected to RUC. Their ministry is truly invaluable. Thanks are due, too, to Elaine Hints for her continued ministry with Families Connect - sending cards and letters to baptismal families and to those who have lost loved ones.

Our buildings continued to be used by community groups for some of the year. Groups such as The Moreton Bay Regional Community Legal Service; Department of Child Safety, Youth and Women; Photography Club; Indigenous Women's Yarning Circle; Presbytery; Developing Lives Counselling Service; UnitingCare, Kinship & Foster Care; Men Choosing Change; and Peta Taylor (Counsellor). The building was also used for funerals, special events, music rehearsals, our usual church groups, committees, and ministries. We didn't renew our lease for Amity Place at Woody Point and handed back responsibility and management of this venue to Moreton Bay Regional Council. By doing this, all our attention can be focused on RUC and the Community Hub.

What a year! We are thankful to God.

## CHILDREN AND FAMILIES

The Children and Families ministry is made up of Jzone, Families at Five, Playgroup, Day Camp, Creative Ministries – Drama & Puppets, and Creative Ministries – Lyrical Dance.

**Jzone**

An age-appropriate bible-based Sunday School program designed for kids in three different age groups.

Term 1 - face-to-face

Term 2 & 3 – online

Term 4 – back to face-to-face

During lockdown, lessons were prepared and sent to all families on a weekly basis. We empowered families with activities (story, prayers, crafts, videos, songs) to do at home together.

Themes in 2020: Meet the King; Bible Ninja; Animals in the Bible; Old Testament Stories; See What God Does; Wreck-it Pete (stories of Peter).

Most of our special services were cancelled this year. However, during Covid, we started a small drama group to help present the kids' Jzone lessons via Youtube. This group grew and has continued as 'Creative Ministries – Drama'.

Our Christmas Jzone service was fantastic, with about 45 kids and youth in attendance.

**Day Camp**

- A Presbytery-run Kids Camp in June/July
- Face-to-face planning was prepared but cancelled due to Covid
- Day Camp ran as online Zoom sessions instead
- Very reduced numbers
- Thanks to the other directors, who took the initiative and ran Day Camp, Redcliffe Uniting didn't need to provide as much input this year, as Becky could not be involved

**Creative Expressions – Drama and Puppets**

- A new group was formed during lockdown
- 6-8 kids plus extra adults as needed
- A group that disciples kids through stories from the bible made into dramas or puppet shows
- Presentation via YouTube videos or live performances in worship

**Creative Expressions – Lyrical Dance**

- A new group started in Term 4 by a creative Playgroup mum
- Dance and movement to worship songs
- 4-week trial, with a presentation in worship at the Jzone Christmas service
- 9 regular kids involved
- Families were from Playgroup, Families at Five, and Jzone



## 13 Families at Five

A ministry for families to explore faith in a fun-filled way. It includes different family activities with a bible-based story each week. With a change in leadership at the beginning of 2020, Families at Five was in recess for Term 1. Under Covid restrictions, it has not run at all in 2020. However, it re-launched in Feb 2021.

### Playgroup

There was a leadership change during Term 1. Playgroup ran as usual until lockdown in late March. Once this occurred, we immediately went to Online Playgroup.

### Online Playgroup

This ran for about 16 weeks straight – even over the holiday breaks. Each week a YouTube video was made and shared with our Playgroup community, which included songs, a craft activity, and a story. This was widely shared with our Playgroup families, but also with friends further afield and in other states!

### Term 3

Playgroup came back face-to-face, following a Covid-safe plan, five days per week. We averaged about 50% of the people who were coming before Covid.

### Term 4

Four days per week. We averaged about 75-80% of pre-Covid numbers. All of our partnership programs with UnitingCare - parenting breakfasts, self-care morning teas, parenting courses, cooking classes, and special events - were cancelled for the year. The Intergenerational Playgroup started the year with great excitement. We met two or three times before it was cancelled due to Covid. The impact our church has with families is far-reaching. Throughout Covid, our Playgroup Pastoral Carers contacted all our families via phone or email to maintain contact and encourage them during lockdown.

**CHRISTMAS MISSION**

The Christmas party for children under the care of the Department of Child Safety, Youth & Women was a wonderful success. Under the Covid plan, the party was divided into two sessions to reduce the numbers attending at one time. The children enjoyed a petting zoo, face painting, and opening over 300 presents. They also had the chance to meet with their parents for the last time before Christmas. The Department asked us to cater for 100 children plus parents, and I am sure that across the two sessions we came very close to that number.

The Christmas hampers were also a great success. The Breakfast Club, Redcliffe Uniting Church, The Salvation Army, Encircle Redcliffe Neighbourhood Centre, and the Redcliffe Mother's Group all combined their resources to provide food and toys for families in need. The Beef Bank donated enough frozen mince to provide each hamper with a 500g pack. St Andrews Hospital donated two trailer loads of toys and food, and the presents from MBRIT helped top them up. The money MBRIT donated helped us fill any gaps in the food that was donated and also gave us the opportunity to add a 1kg pack of bacon and 1 doz eggs to each of the families and couples' hampers.

December 18th was our packing day, and the Breakfast Club Hall was full of volunteers from all of the care organisations involved. I estimate that there were probably up to 80 volunteers there on the day. Then we had the distribution days on the following Monday and Tuesday, where there were at least 30 volunteers on each of the days. We packed and distributed 185 family hampers and 195 singles' and couples' hampers, that were either taken on those days or in the days that followed. The hampers and the children's Christmas party were a success. Thank you to all who contributed.

## COMMUNITY GARDEN

It will come as no surprise that 2020 was not a great year for community outreach. So, a major focus has been on 'treading water', just keeping things going until times are more conducive. The original plan was to try to form links with our local Kindys with some low level environmental activities, and to link with Redcliffe High School on a program where students volunteer in the community for BCE points. Both of these things will be investigated further in 2021. While the main focus became one of maintenance, some progress was made.

“Glenda Gorrett and Polly Lau volunteered consistently, with Glenda in particular doing an amazing job on the weeding. Polly has floated the idea that she may rent Hub space to hold Chinese Tea Ceremonies, which would also be a welcome addition. We also created a 'yellow' garden to make the church look more welcoming, with some smaller gardens also being added and/or revamped. Down in the Community Garden area, we still have a parade of regular visitors, often outside normal church hours. These people bring their children or grandchildren to play for a while, stop for a bit while walking their dogs, spend some time when they are attending for child access visits with the Department of Child Safety, or just drop by unseen. We know this happens because things are picked or moved or added. As the aim is to be a friendly face to the world, all these things, no matter how small, are welcome.

As an example, this year some of our 'across the road neighbours' donated a garden bed and some sleepers, which were very welcome. Someone else added coconut fibre to our gardens, to help them hold moisture, and hung a coconut planted with a little orchid from a tree branch. Thanks also to the church people who supported us, with gifts of plants, an outdoor table, donations to the compost bin, etc. It all gets noticed and appreciated, and with the Hub coming this year, the opportunities for outreach are increased.





Candy Hunter worked very hard throughout the Covid lockdown and restrictions. While most staff were working from home, Candy used this time to repaint the church offices. New carpet was then laid, and this revamp has made a huge difference to the overall feel of the space. Glenys Mullan kindly repainted planters, which were filled with greenery that we can enjoy. Candy also refreshed the church foyer with help from Dorothy Hurst and Mel Degaura. This was completed nicely with a new 'welcome home' sign and some new furniture, which was kindly donated by a church member.

Mid year, we became aware of a grant available for infrastructure and were successful in our application. This brought us \$50,000 that we were able to use to update our electrical board and aircondition our hall. We have attracted several groups wanting to hire the rooms since the installation of the air conditioning.

## REDCLIFFE COMMUNITY HUB

2020 brought much momentum for the Community Hub project. In February we were relieved to hear that our Development Application had been approved, and with no community opposition.

After a congregational vote to proceed, we entered the next stage of the project, which was the Detailed Design phase. This required architects to prepare detailed design drawings, so that a builder can build the final design, as well as layout and colour choices. We are grateful for our project manager, Matthew Neale, from Hammond & Neale, as he leads us through all of these processes with such enthusiasm and attention to detail.

In May we received a \$300,000 loan from Presbytery to fund the Detailed Design phase of the project. We are now close to appointing a builder after completing the Tender phase.

We continue to see God's hand at work in this ministry. Some of God's generosity through 2020 came through a government infrastructure grant that we received. This was worth \$50,000 and covered the cost of updating our electrical box. In effect, this meant one less job being added to the Hub project. This really did come about at just the right time, enabling the electrical upgrades that were desperately needed.

We also saw God's provision through the many skilled volunteers who gave us hours of their personal time to bring us through each stage. I would like to make special mention of Kathy Campbell, who chaired our Steering Committee. When Kathy stepped aside from this role and the committee, Leigh Bennett kindly took on the Chair role. Later, Tony Hunter became Chair with Leigh Bennett, Carol James (Steering Committee Secretary), Kerri-Anne Dooley, Wes Bleakley, myself (Fiona) and Paul Clark also serving on the Steering Committee. God kindly brought us Ralph Collins later in the year, to help with finances. We often invited Greg Adsett to join these meetings along with Matthew Neale, our project manager. I would also like to thank Ally K, from Encircle Redcliffe, for attending some of our meetings and offering invaluable support.

Late in 2020, another provision of God - the partnership with UnitingCare to fund a Community Chaplaincy role, to be based in the Hub. Tim Griggs was affirmed for that role.

Tim will continue to help us become mission-ready for the Hub, empowering us to connect with those who come on site.

In November of 2020, another one of God's provisions came in the form of the Moreton Bay Regional Council offering us a fee remission for the Hub to the value of \$96,000. We are very grateful to MBRC for this.

I see the excitement building in the church and wider community as we get closer to the Hub becoming a reality. The leading for RUC to take on such a ministry is very obviously from God.

His provision of finances, family, and favour continues to propel us into each next phase. We truly see the RUC Community Hub being the place where lives are transformed.

It won't be long until we will be sharing God's love over a coffee with our neighbours in the cafe and showing them that church is not so inaccessible.

## THE REDCLIFFE EXPLORERS

As with many groups, our normal schedule was severely interrupted by the Covid-19 situation, but we did manage several meetings throughout the year, observing strict safety guidelines. These included: a continued study of John Gunson's book, *God, Ethics and the Secular Society*, with Ian Brown providing a 'refresher snapshot' and Graeme Adsett following this up with an in-depth review of the chapter 'Religion as Mythology'.

Watching a podcast sermon by Rev Dr Roger Ray (Emerging Church, Springfield, USA) on mortality. He examined the question that maybe this life is all that there is, and suggested that if indeed we are mortal, and there's no 'after-life', we'd be very well advised to make best use of the allotted time we have. A lively discussion ensued about the 'soul' and what we mean by the word.

Ian Brown introduced Rutger Bregman's recent book *Humankind: A Hopeful History*. Bregman postulates a radical idea, which is ignored by the media, denied by religions and ideologies, and erased from the annals of world history. At the same time, it is legitimised by virtually every branch of science, corroborated by evolution, and confirmed in everyday life. It's an idea intrinsic to human nature that goes unnoticed: it's simply that most people, deep down, are pretty decent.

To illustrate, he compares the (fictional) story of *Lord of the Flies* by William Golding, with the (true) story of the Tongan schoolboys marooned in 1966.

We later focussed on Bregman's analysis of Jesus' directive in the Sermon on the Mount to 'turn the other cheek', and how this has influenced the development of a very successful progressive form of prisoner incarceration and rehabilitation in two Norwegian prisons. The discussion that followed revolved around the inadequacy of Australia's prison systems, and what (if anything) we could possibly do about it.

At the year's final formal session we welcomed guest speaker, John Beattie, a member of the Religious Society of Friends, or 'Quakers'. John gave us a detailed account of the Quakers' history, its many influential people, what happens at their gatherings, what they do (or don't) believe, and, of course, the significant work of Quakers in anti-slavery and the advocacy of pacifism.

Anyone interested in grappling with humanity's Big Questions and engaging in serious, robust, but polite discussion is most welcome at our meetings. We gather on the first Monday of the month at Azure Blue (Anzac Ave. Redcliffe) at 6pm.

## WELFARE REPORT

Changes were made in 2020 to the way RUC handled the needs of the community and our church members. Mark Millard was asked to take on the role of Welfare Officer to oversee the combining of the arms of the church that cater for those needs. Giving from the Heart, Christmas Hampers, and general need requests all now come under the Welfare umbrella. This new system has worked well and has given RUC a better understanding of where money needs to be spent and how to spend it.

The work of Giving from the Heart continued throughout the year, with requests for towels, sheets, pillows, blankets, summer and winter pyjamas, nit treatment, and emergency packs all being provided to the Department of Communities.

We have developed a great relationship with the craft group at Azure Blue, who have provided us on two occasions with knitted and crocheted blankets, jackets, beanies, babies socks, and other items that have been passed on to the incredibly grateful children in the care of the Department.

The highlight of the year for GFTH was the Christmas Party for the children under the care of the Department of Child Safety that we held at RUC and was catered for by our wonderful catering team. More than 300 presents were provided for the children and as much food as they could eat, as well as a chance to spend some time with their biological parents before Christmas.

During the year, whenever Covid restrictions allowed, Mark attended the Redcliffe Care Network meetings. This group works throughout the year to help meet the needs of the poor in our community, with the final goal of providing hampers at Christmas. The members of the Care Network changed slightly in 2020, with Vinnies, El Shaddai (now known as The Food Stache), and Clontarf Baptist stepping back, and The Salvation Army, Redcliffe Mother’s Group, and MBRIT joining with RUC, Encircle Redcliffe, and The Breakfast Club.

In 2020 The Breakfast Club was able to host the hamper sorting and distribution, and we had Beef Bank come on board to provide 500g of frozen mince for each hamper. I thank all those members of RUC who volunteered to help with, donate to, or provide goods towards the hampers. It was a tremendous experience, with the needy incredibly happy with what they received.

There were numerous calls and emails for help throughout the year, and all were dealt with successfully. My thanks go to everyone who has donated or helped in any way towards the welfare of those in need in our church and in the community, of which we strive to be at the heart.


## WORSHIP

With so many people in the 'vulnerable' category, we had to recruit and build a new Sound Team from scratch. We salute and thank the original Sound Team, especially Stan Elledge, who retired from his role as Sound Team leader during Covid.

We had an ice-cream/coffee van for a number of weeks - (remember that?) - and slowly began to bring back our barista coffee.

Slowly, people's confidence grew and our 'in person' numbers began to eclipse our online numbers. Overall, our community has grown, and we love our 'diaspora' members. What has been amazing is that since returning to live worship, and having to sign in, every week we see that someone new has been in worship, and every second week it's been someone's first time back in worship. We also continue to send out 30 DVDs of our services each month to people who can't physically come and who don't have internet access.

People have been joining our worship, music, morning tea, sound, and video teams. It's wonderful - and the new drama and dance groups have been an added blessing.
